Customer drawing PCB layout shows the header pin thru hole at DIA1.38+/-0.10 This hole size is too small for the header pin size and is changing to DIA1.75+/-0.10

Reason for Changes:

Document Clarification. The current PCB thru hole size is too small for the header pin diameter and is changing to add greater hole clearance. There is no change to the header pin size or the product in general, this is only an information change on the customer drawing
