Reason for Changes:

Product Improvement. Dear Customer, in order to identify parts manufactured in the TEC Suzhou (China) facility we are adding part number marking per the images above. This change affects only the appearance on DT2 and DT3 plug and receptacle connectors. Form, fit, and function are not affected by this additional marking. Shipments of both versions may be mixed. IMPORTANT: This is a continual improvement, so the current and previous revisions of these parts can be used interchangeably in the field. The additional identification is being phased in gradually and previous revisions can remain stocked until use. A note will be added to the product drawing to indicate that the marking is optional and to be used only when parts are manufactured in China. Reference PCN E-19-004598 for part numbers.
