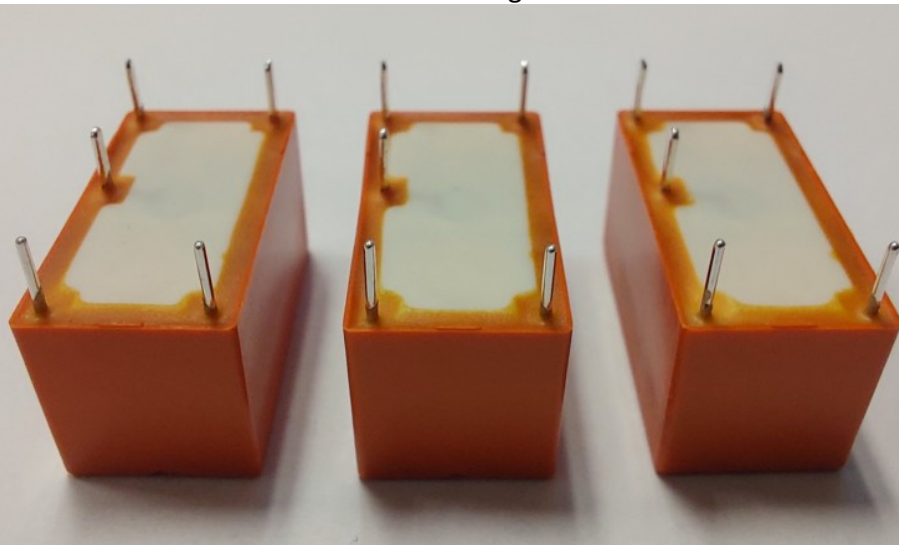

### Description of Changes

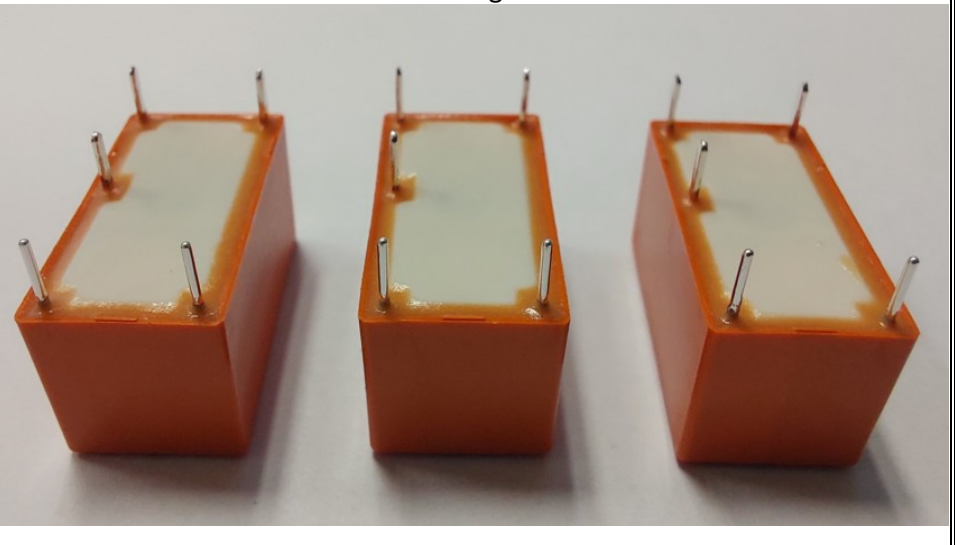
Dear customer, this PCN is a correction of PCN-22-125558 as we do not make use of a white adhesive but have qualified an orange adhesive. The reason for the change keeps the same: To keep aligned with the regulations of RoHS not just for the finished relay but also throughout the complete process of production we change the sealing adhesive. The following qualification tests did not show any difference to the current adhesive: contact compatibility test, thermal endurance, mechanical endurance, relay tightness test.
