**General Product Description:**

Product Specification 108-1093 for AMPMODU System 50 Product

**Description of Changes**

Changing the contact retention force in the housing from an axial load of 2 pounds, to an axial load of 1 pound.

**Reason for Changes:**

Document clarification. The System 50 product was created in 1989. The product was qualified to the previous 108-1093 Product Specification which had the force as 2 pounds. Around 1995, the contact design was changed from a latch style retention to an interference fit style retention. The retention of this new style is slightly lower than the latch style for obvious reasons. However when this design change was made, the Product specification was not updated for the newer Contact retention value.
