Description of Changes
This PCN is an addendum to previous AMPSEAL PCN numbers E-18-008460. In an effort to maximize our capacity, our intent is to move the molding of the header housing and the dispensing of the flange seal material on the header assemblies from the current TE molding and assembly manufacturing location to a new single TE manufacturing location in Empalme, Sonora, Mexico. This second TE facility is located in the same compound as the current TE facility.

Reason for Changes:
This product line has seen extensive demand increases from our customer base.
