Please be aware of an upcoming feature change to the listed part numbers. Before: The product was supported on the PCB by means of 4 standoffs at 4 corners. After: Standoffs are now integral part of 2 side walls. Further the inside walls that separate the individual poles now reach the PCB surface and are visible by looking at the product from front. The draft of some surfaces on the back of the terminal block has been slightly increased. No change in Overall dimensions.
