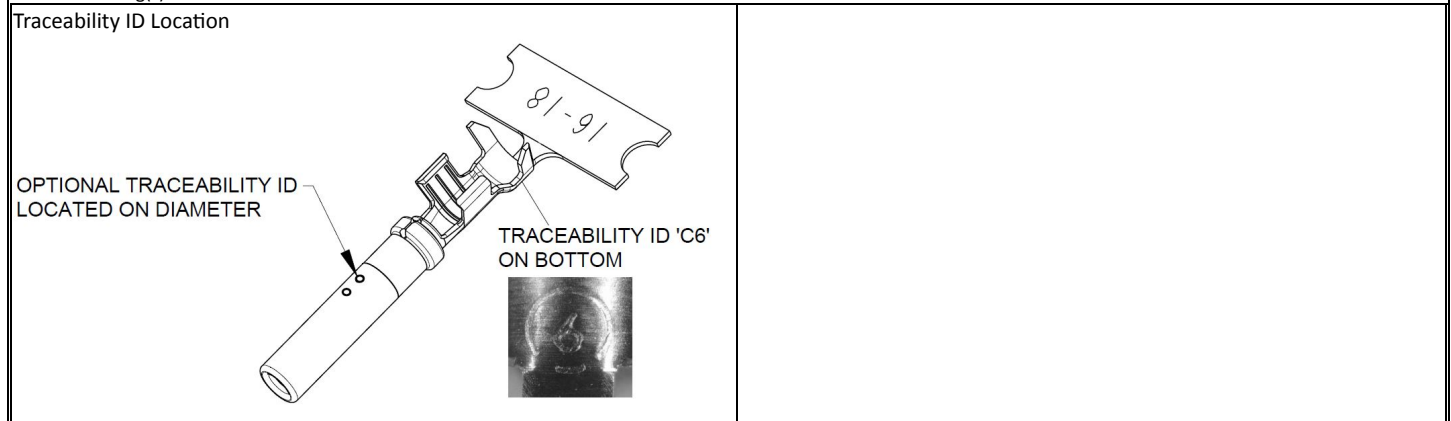

These protective sleeves are used on DEUTSCH size 16 sockets that has a traceability ID C6 located on the bottom side of the insulation grip. Also, the sleeve will have optional two small dots on the diameter to signify they were made in China. See attached.
